1. **Risk Acceptance.** Participant (and their Parent/Legal Guardian when applicable) accepts that playing tennis involves physical exertion which increases the risk of health complications, overexertion, and injuries that can occur, through no fault of any person, from the exercise offered at Middlebury Indoor Tennis. Participant (and their Parent/Legal Guardian when applicable) acknowledges that there is no way to eliminate these risks, and knowingly and voluntarily agrees to assume all risks related to this event or in any way arising from member's activities while on MIT premises or the premises of an MIT-sponsored event, and specifically including the risk of negligence by others, including loss, damage or injury to the member or their property.
