You gain access to our planned giving experts to help you explain the various options to your donors and arrange the appropriate gift vehicle. We handle all the administrative and investment functions, and at the death of the income beneficiary, the assets remaining in the account establish or are added to a designated fund for your organization.

The following organizations participate in the planned giving partnership program, and the (*) denotes those have arranged a gift through this program. Since beginning the program in December of 2002, thirty-four of our partner organizations have issued 129 gift annuities, ranging in size from \$15,000 to \$250,000, with a total gift value over \$5,900,000. The average size annuity is close to \$91,000 and the median size is \$25,000.
